**Opinion by Shawn** - As a long time member of MA Audubon, on MA Audubon's Advisory Council, teaching for Audubon for 20+ years, and as past president of Eastern MA Hawk Watch and other groups, Shawn spoke of his feelings toward game farms. It is one thing to photograph wildlife in wild places and another to photograph captive animals in locations where they aren't wild. There are game farms, certainly in other countries, where animals when they aren't performing, are being mistreated and sent off to be hunted and shot. There are things that take place that are objectionable, and as a Chairman, Shawn wanted to make his feelings known. Rolling Stone is coming out with an article on this topic.

While photographing wildlife in general, the hope is that everyone in this group will all respect the bounds for which we should be conducting ourselves in the field. There are the right things to do and other things that shouldn't be done to harass wildlife.
